Magic of IL – We Have History!

> We have experienced, advocated against, and survived:

- State and federal policy: farming out, institutionalization, segregation, forced sterilization (1907: Buck v. Bell)
- Eugenics & Euthanasia (America influenced Germany's T4, Law for Prevention of Hereditary Disease, and Law Against Dangerous Habitual Criminals and Sexual Offenders, <u>Oregon's Death with Dignity</u>)
- Stigmatization, ableism, and systemic bias
- Denial of love, marriage, sex, family (termination of parental rights of parent with disabilities)
- > Human trafficking, sexual assaults, hate crimes, trauma
- Inaccessibility, unequal education opportunities
- > An astonishing unemployment and poverty rate
- State and federal budget cuts and unfunded mandates

Magic of IL - EOCIL

- EOCIL was initially formed in 1997 and started providing direct services in January 2000. USF Advisor – <u>Mary Lou Breslin</u> (DREDF), Peer Mentor – <u>Mark Dore</u> (Area Director/Statewide Coordinator for the Deaf and Hard of Hearing at the Commonwealth of Massachusetts).
- EOCIL is in rural Oregon. 5 offices (in Burns, Ontario, La Grande, Pendleton, and The Dalles) and provides services in 13 counties.
- Our Demographics (47-member team)
 - ➤ 100% of board and team members are PWDs
 - ➢ 75% are members of the BIPOC community
 - ▶ 45% are members of the 2SLGBTQIA+ community
 - > 25% are members of the substance use community
- EOCIL adopted a funding formula. Our annual budget before the funding formula was \$700,000 – IL base funding of \$265,000. Our 2023-24 annual budget is \$6,000,000, and IL base funding is 4.4%.
- 55% (direct service) 25% (systems advocacy) 20% (other tasks) Standard to guide our strategic plan and services for our local, state, regional, national, and international priorities.



Magic of IL – EOCIL: Purpose & Programs

EOCIL has two purposes:

- Operate the Institute for Disability Studies and Policy (IDSP). IDSP is our systems advocacy arm. It produces actionable research for independent living systems around the world.
- EOCIL operates programs that provide <u>direct IL core services</u> for PWDs (since 2000, we have served 132,614 5,765 monthly average) in eastern Oregon.

EOCIL Programs

- Institute for Disability Studies and Policy Research Department
- Independent Living
- Crisis and Emergency (community gardens, food co-op, well water, cancer, STI, and HIV screening)
- Sexual Health (HIV testing and prevention, linkage to care, HIV re-engagement into care and support services)
- Harm Reduction (PEP, PrEP, Harm Reduction Tools syringe/needle exchange, condoms and lube, etc.)
- ➢ HIV Community Services (U=U)
- > 2SLGBTQIA (youth services, hate and bias reporting, advocacy)
- Housing
- Trauma-Responsive Behavioral and Mental Health Services

Magic of IL – EOCIL: 5-Year Systems Advocacy Plan

EOCIL's 5-year systems advocacy plan focuses on 5 priority areas (housing, healthcare, education, employment, and accessible cultural and leisure). We focus on four areas of barrier removal for each priority. For example:

Magic of IL – EOCIL: 5-Year Priority Communities

- EOCIL's 5-year priority communities were identified through a community survey, strategic plan, PPR data, and the Oregon SPIL, and we juxtapose state, regional, national, and international plans
 - ➢People with Disabilities
 - Gay or Bisexual men who have sex with other men or same-gender loving community
 - Transgender community
 - Sex worker community
 - People who are institutionalized in prisons and other closed settings
 - People who inject substances community
 - Migrants, minority ethnic communities, and BIPOC communities

Magic of IL – EOCIL: IDSP

EOCIL's IDSP 5-year systems advocacy priorities

- Assist USICD with U.S. ratification of UN Treaty: Convention on the Rights of Persons with Disabilities (CRPD)
- Nationwide repeal of termination of parental rights of parents with disabilities solely based on disability
- Increase access to accessible and affordable housing
- Increase access to behavioral and mental health services
- Increase base funding for CILs CILs can provide livable wages and benefits!

Magic of IL – EOCIL Example

Growing Housing Crisis in Eastern Oregon

- ➤ Housing inventory \$\$\$\$
- Regulations for improving properties Permits for remodeling can take 1+ years and \$\$\$
- Non-existing trauma-responsive housing property management
- Housing costs exceeding 30% of affordable housing standard, lack of subsidized housing options, and increased interest rates discouraging property ownership
 - Increase homelessness
 - Decreases access to accessible and safe rental or ownership options
 - Increases food insecurity
 - Increase interaction with law enforcement
 - Decreased access to behavioral/mental health services (6 8 months for assessment)
 - Decrease access to healthcare options

Magic of IL – EOCIL Example: EOCIL's Solution

EOCIL's Solution

- Systems advocacy Governor, state legislators, Oregon Health Authority, foundations, state and local planning and zoning, law enforcement, local elected officials to make housing priority in state planning and invest \$\$\$ in housing options
- EOCIL added trauma responsive behavioral and medical health teams providing access within 24 hours
- EOCIL purchased properties and added 14 traumaresponsive free-no rent transition apartments (\$1.3 million)
- Architect plans for stacked container housing options
- IDSP joined national research project to evaluate if our trauma responsive housing interventions can be replicated – evidence base practice
